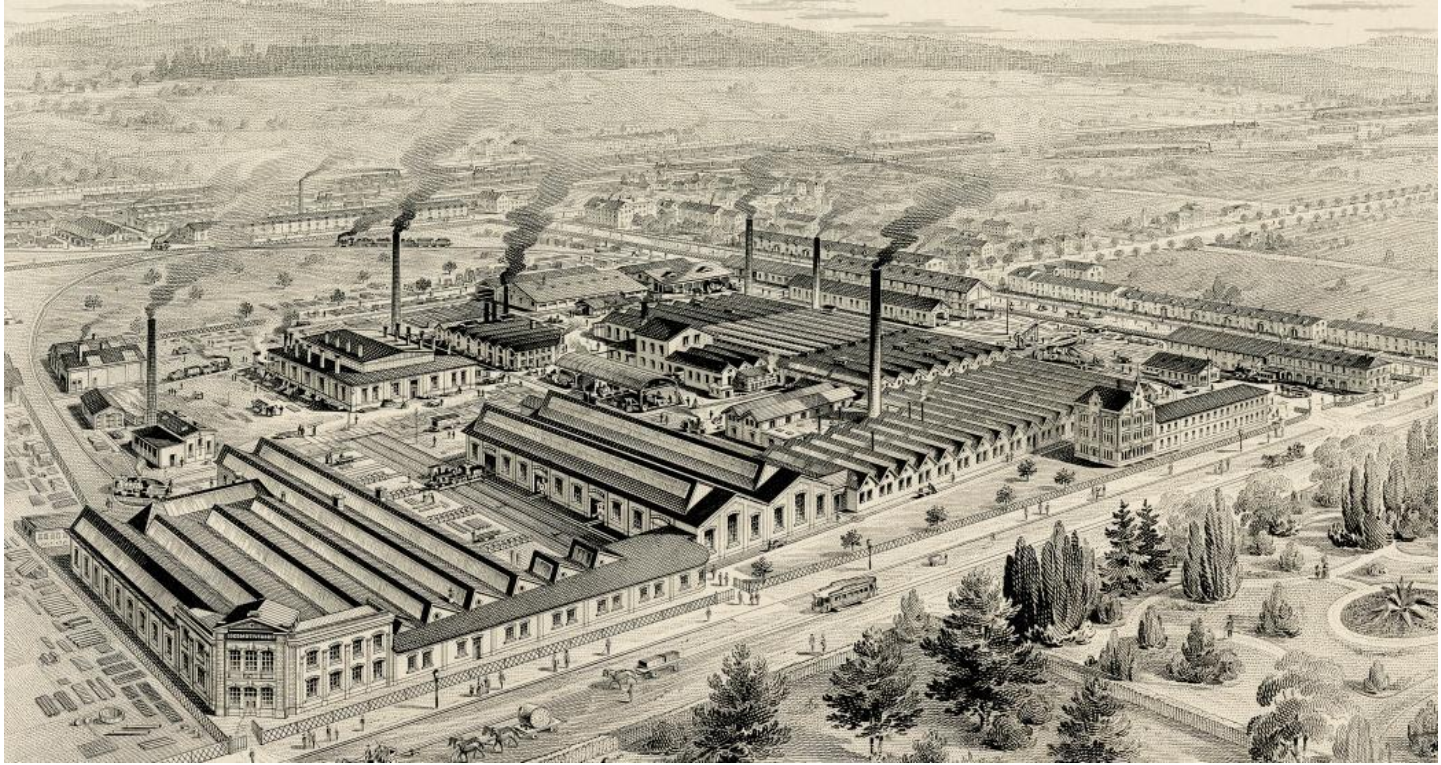

VORGABEN RUND UM NACHHALTIGKEIT

- Vorgaben zum **Denkmalschutz** für:
 - Halle 1007 / **Draisine**: Dachform und Tragstruktur
 - Halle 1012 / **Habersack**: Dachform, Tragstruktur, Stirnfassade Süd
 - Halle 1013 / **Rapide**: Möglichst umfassende Erhaltung des Raumeindrucks, innere Tragkonstruktion muss sichtbar bleiben
- Autoarme Nutzungen haben Vorrang. **Fahrten des MIV** und Parkplatzzahl **werden begrenzt**.
- Min. 30% der Wohnflächen sind für **gemeinnütziges/preisgünstiges Wohnen** vorzusehen.
- Neubauten und neubauartige Umbauten müssen dem jeweils **aktuellen SIA-Effizienzpfad Energie** gerecht werden.
- Es besteht eine Anschlusspflicht an die **Fernwärme** der KVA.

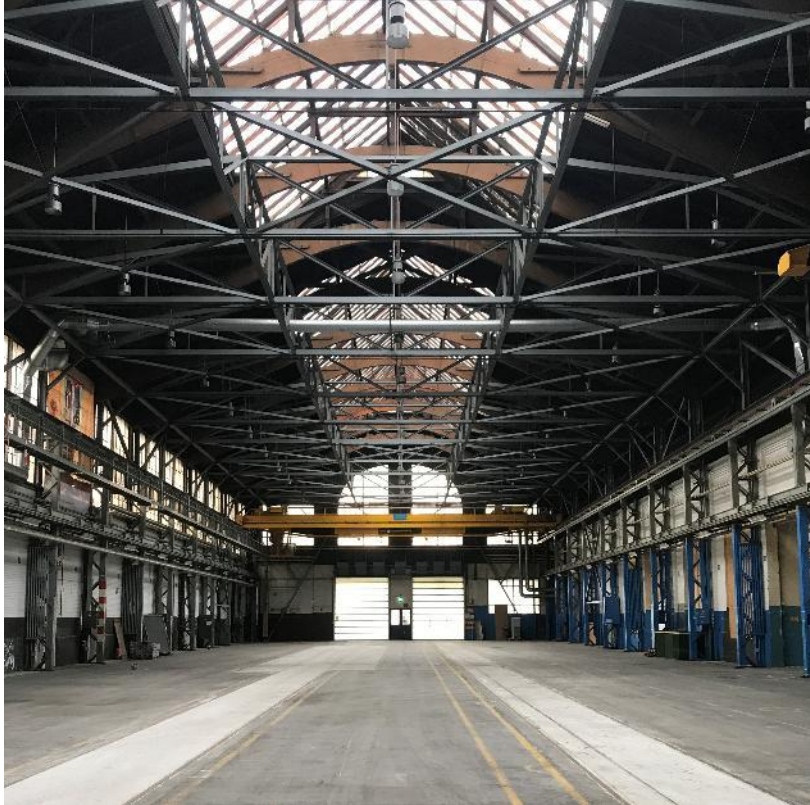

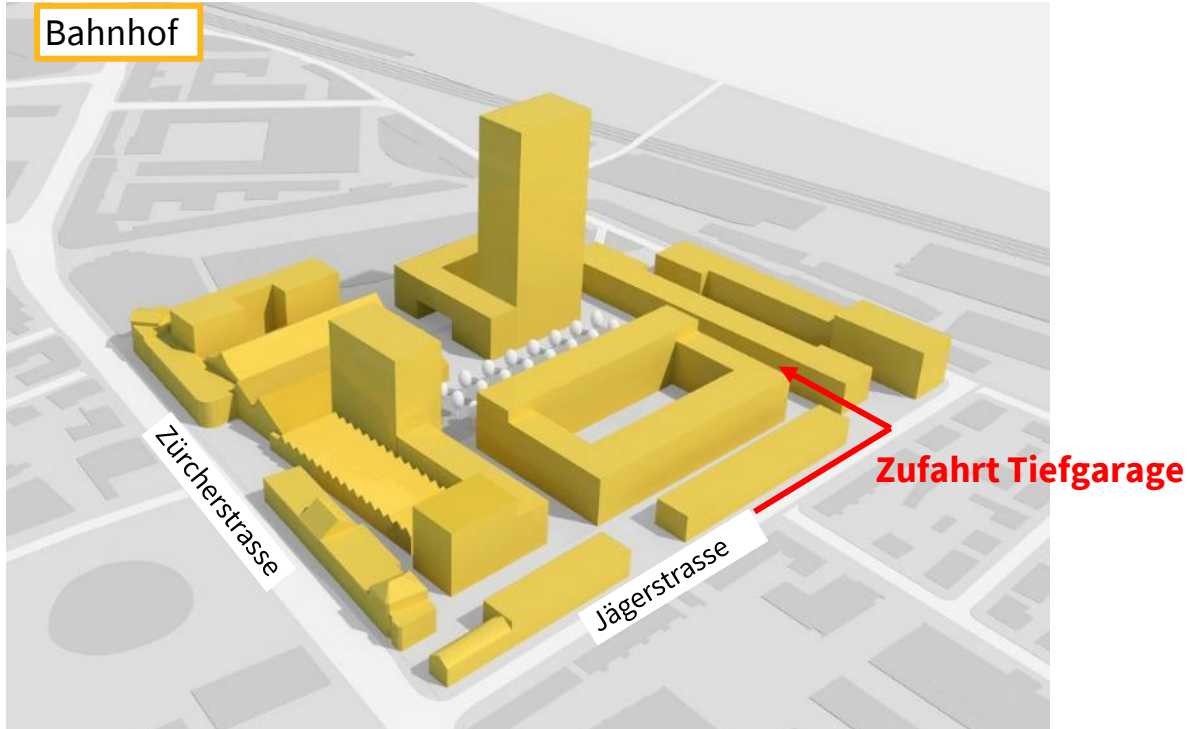

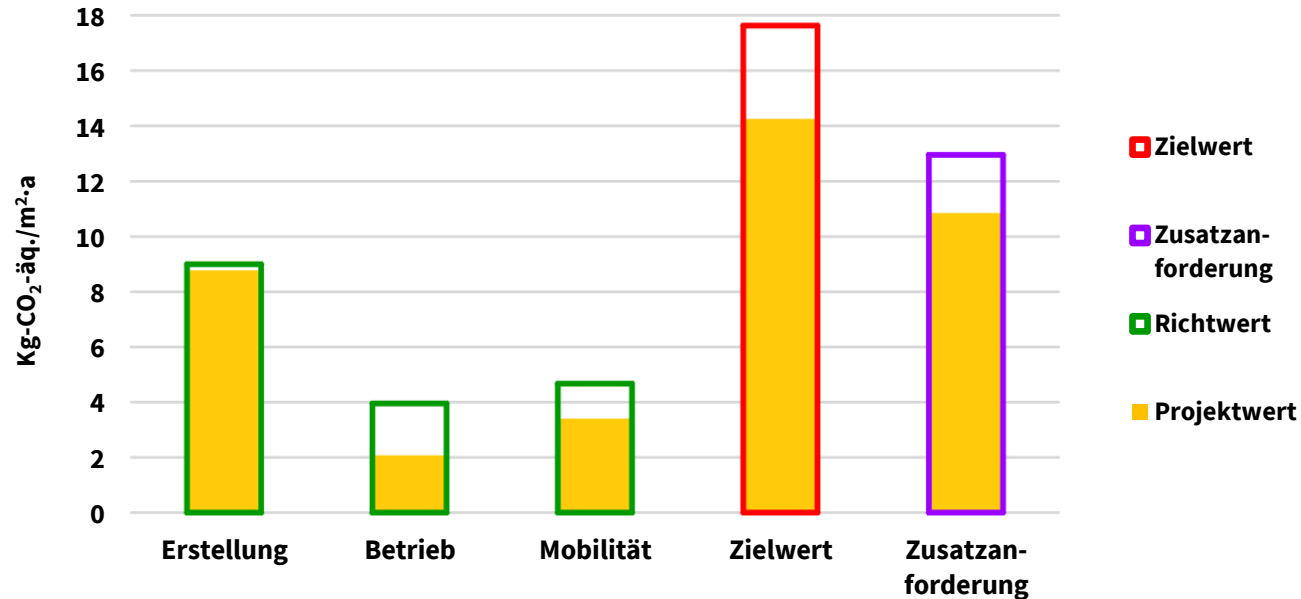
